The review, reform and development of laws by the Commission contribute significantly to the priorities of Government. It results in updated laws which serve the needs of Samoa, based on research and analysis, submissions from the public, and public consultations with stakeholders, village communities and the public.

### EXECUTIVE DIRECTOR'S NOTE

As the 12th Financial Year closes for perhaps the most challenging, yet the most rewarding year for the Commission, I present this Report on the significant developments of the Commission's Projects being the Key Performance Indicators for this Financial Year 2020/2021. I would also like to take this time to report back on the Commission's work and its significant achievements specifically in relation to the most important Project the Commission has ever received a Terms of Reference on and delivered, the Fetuunai Muniao Project (FM Project).

### Fetuunai Muniao - The 3 Acts

### (Constitution Amendment Act 2020; Land and Titles Act 2020; Judicature Act 2020)

By way of background, the FM Project was initiated by Cabinet Directive FK (19) 31 dated 20 September 2019. FK (19) 31 directed the Office of the Attorney General (OAG), the Ministry of Justice and Courts Administration (MJCA) and the Commission to research and provide recommendations on a subsequently endorsed Terms of References which is as follows.

TOR 1 - To review and research the laws of Samoa on how customs and usages can be recognised and protected under the Constitution, within the ambits of the Constitution;

TOR 2 - To review and research the laws of Samoa on how the LTC can be an autonomous set up from the formal courts, within the ambits of the Constitution; and

TOR 3 - To make recommendations.

Following our last update in our last Annual Report for the FY 2019-2020 on the progress of the extensive work the Commission carried out alongside the Team of the 3 Offices, the aspirations and hopes for the passage of the 3 Bills that were resultant from this Project became a reality on 15 December 2020. At this last Parliament Sitting of 2020, the 3 Acts were passed and thus enacted by the Parliament of Samoa.

Following the enactment of the 3 Acts, the Commission were then tasked with reviewing and revising the three (3) Draft Supporting Legal Frameworks from the first working Drafts that were developed and referred from the OAG in 2019. By the end of February 2021, the Commission had completed its review and drafting tasks for the three (3) Supporting Legal Frameworks which were then submitted to the OAG and the MJCA respectively for their review.

The Samoa Law Reform Commission is blessed to have been part of this journey, from research to the enactment of the 3 Acts, and the development of the 3 supporting legal frameworks, in moving forward. We have been greatly humbled having had the esteemed privilege of having been a part of this special project, which has reinforced further the importance of our roots and faasinomaga as Samoans.

The SLRC continues to be thankful and would especially like to acknowledge the support of the former Minister of the SLRC, who was also the former Prime Minister, Honourable Tuilaepa Dr. Sailele Malielegaoi. The SLRC is also grateful for the support from the stakeholders and partners who have contributed to the SLRC's Work. To the staff of the SLRC, Faamanuia le Atua i galuega lelei uma.

We can only pray and trust the Lord that Samoa will continue to hold her head up high and be proud of its Government's initiatives to uphold the *customs and usages* of our beloved Samoa, the essence of the identity of OUR people!

### 1. ORGANIZATIONAL STRUCTURE

### 1.1 OVERVIEW


The Commission consists of an Executive Director, Telei'ai Dr. Lalotoa Mulitalo, as the administrative head of the Commission who supervises and directs its work. There is only one (1) Output of the SLRC called 'Legal Research Analysis and Recommendation'. The office now has fourteen (14) permanent staff and three (3) contractual staff; a total of seventeen (17) positions inclusive of 3 vacant positions.

The Commission was also fortunate to engage 2 part timers in this Financial Year to assist the Commission with its work.

The organizational structure as shown below illustrates the organization of the SLRC staff positions.

Law Reform Commission Act 2008, section 10 (Executive Director) – (1) The Executive Director is the administrative head of the Commission and shall supervise and direct the work of the Commission.

### 1.3 MAIN OUTPUT

Under the one (1) main output of the Samoa Law Reform Commission (Legal Research Analysis and Recommendation), performance indicators and targets are provided for implementation. There are different activities identified and set in place to assist Commission in its efforts to provide effective and efficient services, which would overall contribute to the achievement of the Commission's strategic objectives. These activities are funded by appropriations.

The Legal Research Analysis and Recommendation team consists of seven (7) lawyers and is led by the Assistant Executive Director, Sheliza Tapuai. At the date of this report, three (3) legal positions are vacant and are being advertised in the PSC Circular for replacements.

### 1.4 SUPPORT UNIT

The Corporate Service Unit is required to provide full support to the Legal Research Analysis and Recommendation output to ensure smooth and sound implementation of research and reform activities. The Corporate Service Unit is responsible for four key sections of the Office:

- i. Financial Management;
- Human Resource Management;
- iii. Information Communication and Technology; and
- iv. General Administration of Public Relations, Reception and Transport arrangements.

The Corporate Service Unit is led by the Manager Corporate Service supervising six (6) permanent staff.

### 2. ROLE AND FUNCTIONS

The Samoa Law Reform Commission (Commission) was established in 2008 under the Law Reform Commission Act 2008. The Commission undertakes research and provides recommendations to reform the law on topics according to its mandate:


- To research and analyse areas of law considered to be in need of reform in accordance with a
  reference made to it by the Prime Minister, Cabinet or the Attorney General; or self-initiated
  by the Commission and endorsed by the Attorney General or the Prime Minister;
- To consult with and advice the public about its work;
- To provide reports providing its recommendations to the Prime Minister, Cabinet and the Attorney General; and arrange for the publication upon Cabinet approval;
- If recommended in its reports and where capacity allows, to draft new or amending laws or proposed legal framework for the approval of the Attorney General;
- To promote awareness of the laws of Samoa;
- To advise government Ministries and agencies on the manner or content of reviews of the law conducted by those Ministries and agencies.

The SLRC is responsible to Parliament through the Prime Minster, Cabinet and the Attorney General. At the conclusion of each inquiry, the SLRC provides a report to the Prime Minister, Cabinet and the Attorney General that includes evidence-based recommendations for reform. The SLRC makes recommendations that:

- · to promote Samoan customs and traditions; and
- enhance the social, cultural, economic and commercial development of Samoa; and
- ensure that the laws of Samoa are kept in a modern state which meets the needs of the Government and the Community.

Following the progress from the last Annual Report 2019-2020, the Review of the Family Laws of Samoa is now at the stage of conducting public consultations or Stage 4 of the Law Reform Process. The Commission carried out its public consultations for Savaii from the 3 – 7 August 2020. Upolu Consultations were scheduled for the month of November 2020, however, given the strict public movement by the Government because of COVID19, the Commission's public consultations for Upolu were re-scheduled for May 2021. Unfortunately, the Commission's plans to complete its scheduled public consultations were again put on hold following the 2021 General Elections until all post-General Elections matters are settled and a new Government is formed. These public consultations for Upolu are re-scheduled for October 2021.

Due to the importance of this review, the Commission proposed 14 public consultations with the anticipation to cover all the districts of Upolu to seek their views. The Commission is grateful to be able to plan multiple public consultations with funding assistance secured under the Spotlight Initiative. All the preparations for these proposed public consultations are completed including the consultations material, stationeries, venues and other confirmed logistics.

This review was proposed by the Commission following an ad reference from the Honourable Prime Minister on possible reforms to increase penalties for drivers/bus drivers under Samoa's traffic laws. This reference was initiated as a result of an increase in the numbers of accidents involving buses in 2019. The Commission's legislative review brought to light that the traffic laws of Samoa were in dire need of collating, consolidating, reviewing, updating and reform. The Honourable Prime Minister was advised accordingly.

Upon the Commission's proposal, the Honorable Prime Minister approved a Terms of Reference on 29 July 2019 for the Commission to conduct a full review of the Traffic Laws of Samoa.

As per its law reform process, the Commission carried out preliminary research and consultations with the key Government Offices overseeing traffic matters in the country which includes the Ministry of Police, Land Transport Authority, Ministry of Works, Transport and Infrastructure, the Ministry of Justice and Courts Administration and Samoa Prisons and Corrections Services, in September 2019. Due to other urgent projects referred by the Cabinet involving the Commission, the development of the Discussion Paper after its preliminary consultations were put on hold.

The Commission is now finalizing its Discussion Paper for the Review of the Traffic Laws of Samoa. This will be submitted to Cabinet for their endorsement as per usual before the Commission carries out its public consultations. The Commission hopes to seek comments and submissions from the relevant stakeholders and the public on issues and questions raised in this Discussion Paper.

On the 4th October 2019, the Ministry of Police (MOP) sought the Commission's assistance to review the Arms Ordinance 1960, a pre-independence legislation. The MOP noted deficiencies and loopholes in the implementation of this old law including its outdatedness, issues in the licenses control and weaknesses in controlling of arms.

This is in the current work plan of the Commission. Due to Government priorities needing urgent attention by the Commission, the Commission through letter dated 16 October 2019 informed the MOP that this project will be deferred to the latter half of 2020.

On the 30th June 2020 the Commission informed the MOP that preliminary research and analysis had commenced since May 2020 for this project. This Review is still at its preliminary research and analysis stage.

### 4.4.1 FETUUNAI MUNIAO

In September 2019 the Office of the Attorney General (OAG), the Commission, and the Ministry of Justice and Courts Administration (MJCA) (collectively referred to as the Fetuunai Muniao Team (FM Team) or the 3 Offices Team) were tasked by Cabinet as per Cabinet Directive FK (19) 31 dated 20 September 2019 to carry out research relating to communal rights. This directive refers back to the final recommendations in the Report of the Special Inquiry Committee (2016) on the Land and Titles Court.

Given the nature of this Special Project and the strict timeframes directed, the Commission directed its full attention towards the development and the completion of this special project. The Commission played a significant role in the legal research and analysis, in the drafting of the 3 Bills and in providing legal advice and explanation to assist the Special Parliament Committee (refer to pg. 17).

The Legal Team assisted the Special Parliamentary Committee throughout the public consultations stage (see further at 4.4.2, pgs. 20-21) and worked long and after hours to meet the timeframes of this special project.

The Corporate Service Unit (CSU) staffs were continuously on stand-by to provide high quality administrative support needed by the FM Team. The Commission in support of this special project utilised both its human resources as well as finances to cover expenses including staff accommodations and meals, as well as sharing catering costs with the OAG, MJCA and OCLA. SLRC vehicles were also used to transport SLRC staff, MJCA and OAG staff in accompanying the Special Parliamentary Committee from time to time around both Upolu and Savaii.

The diagram below attempts to provide, at a glance, the work of the 3 Offices in the 18 months period from September 2019 to March 2021 to bring the Fetuunai Muniao Special Project to completion.

This special project has been beneficial to the Commission's team of young lawyers in their professional and contextual capacity building in conducting high level doctrinal, socio-legal, cultural, Constitutional law and customary law research and analysis as well as gaining experience from working alongside Members of Parliament, the Office of the Clerk of the Legislative Assembly, the Ministry of Justice and Courts Administration, the Office of the Attorney General, private and public stakeholders and our villages around Samoa.

The most important takeaway for the Commission (both the Legal and Corporate Teams) from this special project is that it has instilled further in the Commission staff how important it is to ensure our values and principles as Samoans are continued to be practiced and nurtured, and the need to hold on to our customs and usages, OUR IDENTITY!

### 4.4.2 AD-HOC WORK UNDER THE SPECIAL PROJECT (as referred from pg.15)

In addition, the Commission (together with the Office of the Attorney General and the Ministry of Justice and Courts Administration) played a significant role in the public consultations carried out by the Special Parliament Committee (appointed by Parliament to consult on and review the 3 Bills resulting from the Fetuunai Muniao Project). These Bills were the:

- (i) Constitution Amendment Bill 2020;
- (ii) Land and Titles Bill 2020; and
- (iii) Judicature Bill 2020.

During these public consultations, the villages raised a number of commonly raised and questioned issues for clarification by the Special Parliament Committee. The 3 Offices assisted the Committee by providing on-the-spot assistance by giving verbal advice or clarifications. For other matters where the 3 Offices had time after consultations or on the way to venues of consultations, material were put together and handed to the Committee as guidance and assistance to respond to questions and issues raised. ### 5 REPORT ON PERFORMANCE

### 5.1 ANNUAL PERFORMANCE STATEMENT FY20-21

As the accountable authority of the Commission, we present the annual performance statement as part of the annual report, which has been prepared for Part XIV of the Public Finance Performance Act 2001 for the 2020-2021 financial year and accurately presents SLRC performance in compliance with the said Act.

### 5.2 MINISTRY LEVEL OUTCOME

The SLRC desired outcome:

"Amended and new Legislation consistent with social, cultural, economic and commercial development of Samoa"

The SLRC has eight (8) key performance indicators to achieve its desired outcome – conducting preliminary inquiries into aspect of Samoan law and related processes for the purpose of law reform. It is through the preliminary inquiries process that the SLRC undertakes rigorous research, analysis and community consultations that underpin recommendations for law reform.

### **5.3 ENVIRONMENT**

The Commission strives to pioneer excellence in law reform that is relevant and responsive to the needs of Samoa.

Within the current allocated budget, the SLRC seeks to maintain 17 permanent staff led by the Executive Director, 10 lawyers and 7 corporate support staff. The legal staff of 8 lawyers led by the Assistant Executive Director has the capacity to work on review tasks. The SLRC is reliant on Government for referrals and accordingly the extent to which the SLRC can meet its performance targets is influenced from year to year by the number of references referred to the SLRC, the prescribed timeframes for these references, the number of lawyers for professional capacity, and the resources made available to conduct them.

In light of this, the SLRC will continue to work closely with the Attorney General's Office and the Law and Justice Sectorial stakeholders to ensure appropriate lead time for planning and sharing resources when new references are referred to the SLRC.

# 5.5 CHALLENGES IN COMPLETING THE COMMISSION'S KEY PERFORMANCE INDICATORS - FY 2020 - 2021

FY20/21 was a very challenging year for the Commission in terms of implementation of planned activities to achieve performance indicators approved in FY2020/2021 appropriations.

In the wake of the COVID19 global pandemic in early March 2020, major consultations of core review on Family Laws were deferred because of the State of Emergency Orders that put restrictions to the public movements. In early 2020, the Commission directed all its resources and human resources to

work on a directive from Cabinet for the Fetuunai Muniao project. The project has provided the Commission with strict timelines to initiate research alongside the Attorney General's Office and the Ministry of Justice and Courts Administration. Due to competing priorities at this stage, the Commission re-adjusted its initial plans and reallocated financial and human resources in ensuring that research activities for Fetuunai Muniao meets the set timelines. As a result, approved Performance Indicators for FY20/21 were deferred to be implemented in the 4th quarter of FY20/21.

Plans for Family Law public consultations scheduled for May 2021 in Upolu were ready for implementation, however, the political climate resulting from the aftermath of the National Election in April 2021 became one of the barriers for the Commission to continue its scheduled public consultations for Upolu.

Again, the Commission was tasked to review its planned activities and needed to further defer its other activities to be implemented in the next Financial Year.

### 6. CHALLENGES

- The most critical important aspect of law review is carrying out research i.e. legal, doctrinal, literature social, philosophical etc. Legal search engines such as Lexis Nexis, NZlii and Austlii are vital for informed law reform. Subscription to these legal research engines is needed for access. The challenge is affordability. The Commission's research is limited without access to these useful databases.
- 2. There was a substantial turnover rate of resigning staff noted in FY2020-2021 financial year. Attractive high remuneration offered from other Ministries and Private sector is the main factor for staff resignation. Also, the legal work in SLRC, research, analyzing, consultations, requires a particular kind of passion for the development of the legal sector in any society. Attracting lawyers to fill these vacant positions continues to be a challenge to the Commission, as there are no longer graduate lawyers available as no scholarship is offered for LLB studies, especially the requirement of experience qualified technical staff. The three (3) vacant positions in this financial year have been advertised on numerous times without success in attracting interested lawyers to initiate the recruitment process for replacements. The Commission continue to seek suitable qualified and experienced staff members for the Office.
- 3. The data and research information collected from review to reform activities already completed by the Commission are very important. The Commission considers that the development of a database to save and store these information for ease of access in the future review is much needed. This is the challenge for the Commission designing and developing a Management Database that aligns with specific needs of the Commission.

### 7. HUMAN RESOURCE MANAGEMENT

### 7.1 STAFF MOVEMENT

### 7.1.1 Resignations

- a. Mr. Ropati Sitivi was recruited as a Driver on the 12 September 2017. Ropati resigned from the Commission on the 30th October 2020 to take up another job with higher remuneration within the Public Service.
- b. Hana Gauta Keti served the Commission for 3 years since she was recruited as a Senior Legal Analyst on the 28th May 2018. However, she resigned from the Commission to pursue other opportunities in the private sector.

### 7.1.2 New Appointments

- Ms. Faau'u Kolia was recruited to fill in the Legal Analyst Position on 19 April 2021.
- b. Promotion of Ms. Grace Lafi Esera to the position of Principal Legal Analyst. Ms. Grace is not new to the Commission; she previously held the Senior Legal Analyst and the Legal Analyst positions since joining the Commission in October 2016.
- c. Promotion of Ms. Lizatalei Hakai Stanley to the position of Executive Legal Office on 21 September 2020. Ms Lizatalei has previously held the Principal Legal Officer at time of promotion.
- d. Appointment of Uiese Falaniko as the Office Driver on 22<sup>nd</sup> February 2021.

### 7.1.3 Internship

- The SLRC occasionally hosts interns from Universities around the Pacific Region and abroad.
   The internship trains studies from those Institutions who hope to join the legal profession.
   More importantly, this allows the Commission to build working relationships/ networks with these Institutions.
- This Financial Year 20/21, the Commission was unable to host interns from overseas Universities because of the current restrictions to borders due to COVID19. The Commission is very keen in welcoming more interns in the years to come when the global pandemic ceases and borders are open again.

### 7.1.4 Part Timers

- Due to the difficulty the Commission had in recruiting staff, the Commission sought other avenues to benefit also new graduates without employment. One such programme that has been quite successful is engaging part timers which was previously done by the Commission.
- In this Financial Year 20/21, the Commission was able to secure 2 part time positions approved by the Public Service Commission. The following are the part timers who both commenced work for the Commission on the 12th April 2021:
  - i. Christina Waganui; and
  - ii. Noelapomaiikalani Alatise.
- Both these females are university graduates and are currently employed by the Commission for 3 months. They undertake research under the supervision of the Legal Research Division.

### 9. FINANCIAL AND ACCOUNTS

The approved estimate for the Commission for FY20/21 was \$1,445,678, appropriated for Personnel, Operating Expenditure and Transactions on Behalf of the States. The approved estimate was later reduced to \$1,434,937, a reduction by \$10,741 as a resulted of re-allocation of travel activities during supplementary budget discussions.

The overall spending of the approved estimate for FY2020/2021 was within the approved budget but not fully utilized due to the impact of SOE orders thus delayed implementation of public consultations of ongoing review projects.

### 9.1 FINANCIAL ASSITANCE (GRANT)

### 9.1.1 Sisters for Change

The Commission was fortunate to receive financial assistance from a non-profit organization namely Sisters for Change based in London to fund part of the events of its major review of six core Family Laws of Samoa. The funds were received on 28 June 2019 in the Central Bank Designated Account to the amount of 74,875 Great Britain Pound (GBP) translated to \$249,517 Samoan Tala. At the end of FY2020/2021, about 87% of funds received have been utilized for the Family Law Review. Significantly, this assistance funded Family Laws Public Awareness Seminars held in Upolu and Savaii.

### 9.1.2 UNDP Spotlight Initiative

Project Description: The Spotlight Initiative in Samoa builds on existing Government commitments to ending domestic and intimate partner violence and cultural institutions in Samoa that support ending violence against women and girls. The programme will contextualise international best practice in preventing and responding to violence and learning from emerging practices in determining what works in Samoa.

The Samoa Law Reform Commission comes under Pillar 1 (Laws and Policies) of the programme with the focus on legislative review and reform of the six family laws in Samoa to ensure coherence and to address any gaps relevant to DV/IPV.

Through the Ministry of Finance, an agreement was signed on 14 April 2020 by the Minister of Finance for the Commission to implement two main activities.

- Participatory review of DV/IPV gaps to policies and legal instruments relevant to DV/IPV stakeholder agreement on key priorities to act upon.
- Develop nation-wide advocacy, communication strategy and plans to raise awareness on reform proposal (in line with DV/IPV) and advocate with village councils to recognise DV/IPV laws in line with village laws and legislations.

Total funds allocated to LRC under the Spotlight Programme to carry out the above activities is USD\$76,350. The Commission plans utilize the allocated funds to carry out Family Law Public Consultation activities in the last quarter of FY2021-2022, October – November 2021.
