Welcome to your Law Reform Commission Newsletter for the last six months of the Financial Year 2024/2025.

This issue highlights the Commission's key activities and developments from January to June 2025.

We are pleased to announce the completion of the Review of the Arms Ordinance 1960, with the Final Report submitted to Cabinet for endorsement on 30 June 2025. This marks a significant milestone for the Commission and concludes one of our major projects for this financial year 2024/2025.

The Review of the Traffic Laws of Samoa remains in its Final Report Stage, nearing completion, and the Review of the Fabric of Laws No.2 has also progressed to this final stage of the law reform process.

In addition, one new project has commenced and is currently in its initial review stage:

• Follow-up Review of the Narcotics Act 1967 (initiated by the Commission)

Following the last issue, the Commission's review of the Public Trust Office Act 1975 still in its initial stage due to ongoing discussions surrounding the Terms of Reference (TOR). While approval of the TOR should formally come from the Attorney General's Office, we engaged our Minister and the administering Ministry to facilitate the submission of a request to Cabinet for formal approval. Once this is resolved, work on the review will be able to proceed.

Further updates on the progress of these projects and other activities by the Commission are detailed in this issue.

We sincerely acknowledge the ongoing support of the public, village communities, and Government agencies—your contributions are essential to the success of our work.

## **PROJECT UPDATES**

#### (1) FOLLOW-UP REVIEW OF THE NARCOTICS ACT 1967

In April 2025, the Commission initiated a follow-up on its Review of the Narcotics Act 1967 completed in 2017. To commence this follow-up review, the Commission undertook a stock-take of the recommendations made and the extent to which these recommendations have been implemented by relevant agencies.

The next steps of this follow-up project and any further correspondences and engagement with key stakeholders will be guided by this findings of the Commission's stock-take exercise.

#### (2) REVIEW OF THE FABRIC OF LAWS OF SAMOA NO.2

Following from Issue 1 (July-December 2024), the Commission continued its preliminary research and stakeholder engagement for this project. In February 2025, the stakeholders were invited to one-on-one consultations with the Commission. As of June 2025, 22 out of 25 consultations with government offices were completed successfully.

The Commission is actively following up with the remaining three ministries to confirm meeting times. Preparations of the Final Report are now in progress, with completion expected by September 2025.

### **LEGAL REVIEW ASSISTANCE**

From January to June 2025, the Commission has responded to a number of legal review assistance matters referred (in table below). These references usually require that the Commission carries out legal and doctrinal research, make analysis and provide input and comments to requesting Ministries/SOEs and others. The Commission continues to strive to provide high-quality research-based responses in a timely manner to assist the requesting Government agencies.

#### Virtual Meeting with the New Zealand Law Commission President, Dr. Amokura Kawharu







## CORPORATE PLAN 2025 - 2030









# **PROJECT HANDBOOK 2025**


